Orientation Meeting & Presentation:

Cases will be distributed by email to participants prior to the conference and are encouraged to begin working prior to arriving at the conference. Your solution must represent your own unique ideas. Teams may not accept any assistance from others including, but not limited to peers, faculty members, co-workers or supervisors. There will be a meeting on Sunday afternoon of the conference at 1pm for participants to meet, discuss the instructions, and review the case. One member from every team must attend the orientation to select the presentation time slots. Each team will be given an opportunity to present their solution to the case on Monday. Participants will not be provided with a computer or projector, and are not permitted to use these items during the presentation. Following the final presentation judges will deliberate and announce the winners. On Tuesday, there is an optional session to review and discuss the cases as a group. This is an opportunity to hear both cases and learn from your peers.

Information for Teams:

Teams will be registered in one of two classifications: master's students or new professionals (1-3 years experience).

Teams will consist of 2-3 participants. Participants may register individually to be paired randomly with other members of their classification or may register their entire team of 2-3 individuals.

Participation is limited to 11 groups from each classification. Only 1 group per institution will be allowed.

2. SCLGBTA Paul Hart Fund Scholarship - Applications Due 11 February 2011

Once again, The Paul Hart Fund Scholarships are available to members of ACPA to support attendance at the 2011 meeting of ACPA.

The Paul Hart Scholarship Fund, administered by the ACPA-College Student Educators International, was established in 1995 to provide scholarships for ACPA members who are either living with HIV/AIDS, or have a family member, dependent, partner, spouse, or child living with HIV/AIDS so that they may attend the Annual Convention. Scholarship funds are made available from Paul Hart's estate, and donations are received year-round. Scholarships are made to those individuals who would not be able to attend the Annual Convention without such financial assistance.

Recipients are selected following a review by a committee comprised of representatives from a variety of the ACPA Standing Committees, and the National Office.

In order to be considered for the Paul Hart Scholarship, you must:

- Be a member of ACPA at the time of application
- Put the funds towards attendance at the Annual Convention
- Indicate how receipt of the scholarship will enable you to attend the convention
- Be a person living with HIV/AIDS or have an immediate family member who is living with HIV/AIDS (partner, spouse, children or other dependents who live with you).

*Note- Confidentiality of all applicants and recipients will be maintained at the applicant's request.

Special Issue: Promoting Learning and Development with College Men

There has been increasing attention given to men's development over the past few decades. The discourse has ranged from superficial stories in national media regarding dwindling enrollments to more scholarly interrogation of underlying factors. This special issue will include empirical evidence, theoretical support, and developmental interventions for educators working with men in the context of college and university student housing. Special Issue editors Tracy Davis and Shaun Harper contend that the current discourses regarding men and masculinities are stagnated by an overly simplistic view of privilege and oppression, as well as "essentialized" constructions of identity. As a result, educational practice has not effectively incorporated an analysis of the nuances of lived identities, intersections between identities, contextual influences on the performance of identities, and in turn how these impact residence life cultures. Submissions may be empirical or theoretical, helping residence life professionals understand men's development and behavior or may describe educational practices that have effectively engaged and promoted the success of college men. Examples of potential topics include:

- * Theoretical Perspectives for Promoting Men's Development in Residence Life
- * Using Critical Pedagogies to Engage Men and Promote Inclusive Residential Cultures
- * Women Working with Men in the Residence Halls
- * Successful Judicial Interventions for Men in Residence Life
- * Building a Gender Inclusive Community in Residential Living Environments
- * Men with Intersecting Identities in Residence Halls

We welcome manuscripts from a broad range of perspectives.

A preliminary one-page abstract of the manuscript must be sent to the Special Issue editors by March 1, 2011. Once selections for the Special Issue are made, the first draft for full manuscripts will be due July 15. Abstracts of proposed manuscripts should be submitted electronically in Microsoft Word to tl-davis1@wiu.edu.
