Dr. Brian D. Reed is currently the Acting-Associate Director of Residential Education at Dartmouth College. His research primarily focuses on issues of equity, access, and student success. Prior to his doctoral studies at the University of Virginia where he penned his dissertation on Factors Affecting Low-SES White Male Persistence From Year-One to Year-Two, Dr. Reed held student affairs positions at Dartmouth College, Vanderbilt University, Southern Methodist University, Appalachian State University and Berea College. Dr. ReedÕs publications include Authentic masculinities: A Gender-Aware Approach to Leadership Development and Mentoring, Factors Affecting Low-SES Student Persistence in College, and most recently Socio-Economic and Work Identity Intersections With Masculinity in Davis and LakerÕs Masculinities in Higher Education: Theoretical and Practical Implications. Dr. Reed has also presented nationally and regionally regarding men and masculinities, gender violence prevention, and low-SES student experiences and outcomes in postsecondary education. Dr. Reed is a University of Virginia John E. Merritt Fellow, a Jay Chronister Award recipient, and a recipient of the Jefferson Trust.

We are proud and pleased to have Dr. Reed with us for the coming year - look for the new and exciting work he will be doing with and for us in the coming year!

"Supporting Transgender and Gender-Nonconforming Youth" Edited by Genny Beemyn, Ph.D.

This special issue of the Journal of LGBT Youth will move beyond studies of the experiences of transgender K-12 and college students to discuss ways to support these students. Articles might investigate such issues as:

- --best practices to assist transitioning or gender-nonconforming students --innovative and successful strategies to improve the school climate for transgender people --the implementation of transgender-supportive K-12 or college policies --the policies and practices to support transgender youth outside of the U.S.
- --the incorporation of transgender experiences into the curricula --the development of a transgender ally training program or a transgender-inclusive anti-bullying program
