Professional Development Opportunities – Create and deliver yearround opportunities for professional development, supporting colleagues from entry-level to CHO and addressing every aspect of the reslife/housing operation.

Commission Structure and Governance – Update bylaws to create defined responsibilities for Chair-Elect as a year-long position and Past-Chair as a year-long position, as well as explore updates that may improve our efficiency. This work will improve the overall governance of the Commission and allow for smoother transitions and continuity of service for our members.

Up-to-date, applicable resources - ACPA and CHRL have a long history of providing up-to-date, relevant resources. The resources currently available on our Commission resources webpage however are now fifteen plus years old and no longer represent best practices.

As I mentioned at the outset, I am humbled by the opportunity to Chair our Commission. I ask for your assistance and support as we work together to help our Commission grow and prosper. **In other words - we need you involved!!**
