1. Personal Statement

This form asks for details regarding your conviction(s), including conviction type, date of conviction, sentence, and details of your behavior which led to your conviction. You are required to report any pending charges against you as well. The College would also like to know your educational plans, including your intended major or field of study, or advising purposes. Please attach additional sheets as necessary.

2. Arrest Record

You are required to complete a background to formally document all charges. If you have completed a professional background check within the last 30 days, we can accept that documentation for review. All others should follow the instructions below to properly complete the process:

- 1. Have your credit card/debit card (Visa/MasterCard/American Express/Discover) information ready in order to process payment. Your credit card/debit card will be charged \$30.00 for the service.
- 2. Log onto our website at www.VerifyStudents.com
- 3. Use this special promotional code: **CSCCOSC**; this is a unique code
- 4. Complete profile & e-sign forms as they appear
- 5. A unique login will be emailed to you. This will allow you to log back into www.VerifyStudents.com

Please note this information is for the sole purpose of background screening for this school only. Unauthorized use of our service is prohibited

NOTE: Some language used in the background check mentions employment. Whereas you may disregard the reference, it is important that you complete every question as it relates to your enrollment with the College. Failure to complete any section may delay your application.

3. Letter of Recommendation

You may submit a letter of recommendation from a personal reference such a probation/parole officer, employer, minister, or counselor who can verify that you are ready to attend college and successfully complete college-level academic program.

The information from the screening will be delivered directly to the Office of Student Conduct. The Enrollment Review Team will review your information and notify you in 5-7 business days of the next steps. You may be admitted based on the written information submitted, or you may be scheduled for a personal interview. Criteria for an interview include prior violent offenses, pattern of criminal behavior, and recent conviction or release from incarceration. Your admission to the College will remain in pending status until the review process is complete.
